#### Necessity of spreading awareness among citizens:


Presently, it observes that the crimes like eve teasing, rape are increasing in the society.






FIGURE 1: DATA FLOW DIAGRAM

Candidates may exaggerate or even manufacture a problem with law and order, or characterize their opponents as "weak" on the issue, to generate public support. The expression also sometimes carries the implication of arbitrary or unnecessary law enforcement, or excessive use of <u>police powers</u>.


The **police** are a constituted body of persons empowered by the <u>state</u> to enforce the <u>law</u>, protect property, and limit <u>civil disorder</u>. Their powers include the legitimized use of force.

The term is most commonly associated with police services of a state that are authorized to exercise the <u>police power</u> of that state within a defined legal or territorial area of responsibility. Police forces are often defined as being separate from military or other organizations involved in the defense of the state against foreign aggressors; however, <u>gendarmerie</u> and <u>military police</u> are military units charged with civil policing.

Law enforcement, however, constitutes only part of policing activity.

Policing has included an array of activities in different situations, but the predominant ones are concerned with the preservation of order.

**c.** <u>Magistrate:</u> Responsible for providing generating charge-sheet and arrest warrant.

C. <u>Administrator</u>: Responsible for maintaining and keeping records of all the databases and generating reports of cases.

#### 5. TECHNOLOGIES AND TOOLS USED


The tools and technologies used to develop the website are as follows:
